We are dedicated to supporting programs both locally in Connecticut and internationally in Zambia, Africa. Through our efforts, we donate various tennis equipment and peripherals with the aim of providing a holistic learning experience for players, fostering mental and physical development.

Our ultimate vision is to establish a tennis and enrichment learning center in Ndola, Zambia. Since 2013, we have been actively involved in donating various items to programs in Zambian towns such as Ndola, Kalulushi, Chingola, Luanshya, Kitwe, and Lusaka. These donations not only include tennis equipment but also encompass other learning materials aimed at helping tennis players develop their confidence, capacity, and character.

Locally, we operate after-school and summer enrichment programs in Waterbury, CT, and Brookfield, CT. Additionally, we are in the process of expanding our reach to Torrington, CT, where we plan to offer a National Junior Tennis League (NJTL) program.



The mission of Ability Beyond the Court Inc. is to cultivate stronger, healthier, and more active communities. We aim to instill confidence, improve focus, and promote a productive lifestyle among emerging tennis players and students in Zambia, as well as in programs across the USA. It will stand as a transformative hub within the town, inspiring, nurturing, and educating the next generation of students.

Furthermore, the academy will enhance the prospects of its students or players to potentially pursue collegiate tennis or prepare for their future endeavors. Additionally, our academy intends to initiate in-house projects aimed at fostering sustainable support within the campus and the surrounding community.



# Funding the Project

Over the next year or two, our objective is to identify and secure a suitable location in Ndola, Zambia, conduct all necessary feasibility studies, commence construction, and obtain permits, with the aim of completing these steps by 2025-2027. The initial expenses, including land acquisition, architectural design, equipment procurement, and campus construction, are estimated to require a financial commitment ranging from \$200,000 to \$250,000.
